

Official Online Contest Rules For “The Stampede Getaway Vacation at Mandalay Bay”

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

1. HOW TO ENTER THE CONTEST

a. To enter, go to the web page for this Contest, located on this Web site (http://www.stampedewhisky.com/las_vegas_vacation_at_mandalay_bay.html) (the "Web Site"), and complete and submit the registration form as instructed. Entries must be received no later than 9pm Pacific Time on August 31, 2011. **Only entries submitted electronically to the Web site in accordance with these rules will be eligible for consideration.** Follow the instructions to enter and submit your first name and last name, complete address, city, state, zip code, telephone number, date of birth, and a valid email address in the online entry form. Only one internet entry per person and one internet entry per email address is permitted. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email address or the domain associated with the submitted email address. Indio Spirits, Inc.'s computer is the official time keeping device for the sweepstakes. Indio Spirits, Inc. is not responsible for entries not received due to difficulty accessing the internet, service outage or delays, computer difficulties or other technological glitches.

b. ONE ENTRY PER PERSON.
